****REGULATIONS FOR MEMBERSHIP OF THE PORTUGAL FORUM – SAUDI ARABIA****

Article 1 – General Provisions

1.1 This regulation establishes the rules and procedures for membership, rights and duties of members of the Gate Portugal-Saudi Arabia Association (Fórum Portugal – Saudi Arabia), hereinafter referred to as the "Forum".

1.2 The Forum is a non-profit association that aims to promote cooperation and development in relations between Portugal and Saudi Arabia, through the active involvement of its members.

Article 2 – Membership and Member Categories

2.1 Any individual, company or organization interested in promoting the Forum's objectives may apply to become a member.

2.2 Membership categories may include, but are not limited to:

- a) Individual Member: Individual who joins the Forum.
- b) Collective Member: Companies, organizations and institutions that wish to become members of the Forum.

Article 3 – Application and Admission of Members

3.1 Those interested in becoming members must complete an application form provided by the Forum.

3.2 The decision on the admission of new members is the responsibility of the Forum's Management and is based on the assessment of candidates' suitability for the Forum's objectives and values.

Article 4 – Associate Rights

4.1 Associates are entitled to:

- a) Participate in events, meetings and activities promoted by the Forum.
- b) Access information and resources related to the Forum's activities.
- c) Contribute with suggestions and proposals for the Forum's activities.

****REGULATIONS FOR MEMBERSHIP OF THE PORTUGAL FORUM – SAUDI ARABIA****

Article 5 – Duties of Associates

5.1 Associates have the duty to:

- a) Comply with the provisions of this regulation and respect the objectives of the Forum.
- b) Actively contribute to the promotion of the Forum's objectives and activities.
- c) Pay the association fees, if applicable, in accordance with the amounts and deadlines defined by the Forum Management.

Article 6 – Suspension and Exclusion of Members

6.1 The Forum Management reserves the right to suspend or exclude members who violate the provisions of this regulation or harm the interests of the Forum.

6.2 The suspension or exclusion of a member will be preceded by a fair and impartial disciplinary process, during which the member will have the opportunity to defend himself.

Article 7 – Associative Dues

7.1 Association fees can be established by the Forum Management, based on the categories of members and the Forum's operational expenses.

7.2 Failure to pay association fees within the stipulated deadlines may result in the suspension or exclusion of the member.

Article 8 – Changes to the Regulation

8.1 Changes to these regulations may be proposed by the Forum Management and must be approved by the majority of members at the General Assembly.

Article 9 – Final Provisions

9.1 Any matter not addressed in this regulation will be resolved by the Forum Management in accordance with the principles and values of the organization.

These Membership Regulations come into force on the date of their approval by the Management of Forum Portugal – Saudi Arabia and may be reviewed and amended as necessary to meet the interests and needs of the organization.
